**FEE POLICY**

No Refund of fee even if the child doesn't attend school post admission.

**Annual Fee Due Dates:**

1 st Installment – At the time of Admission or from 1st Apr 2025

2 nd Installment – Sept 1st 2025

3rd Installment – Dec 1 st2025

**One-Time Payment Discount:**

Parents who choose to pay the entire annual fee as a one-time payment at the time of admission will receive a 5% discount on the total fee.

**Mid-Year Admissions Policy:**

Admission until July 31st 2025 has to pay full fee.

Admission from August to January will pay in Pro-rata as below: (applicable to all Fees):

August 2025 - 90%

September 2025 - 80%

October 2025- 70%

November 2025- 60%

December 2025 - 50%

No Mid Term Admissions post December 2025 will be accepted.

**Mid-Year Withdrawal Policy:**

Withdrawal during Mid-year should be done with 30 days notice.

No Refund of Installment 1 Fees

Withdrawal from Sept to March - Proportionate Fee of Installment 2 and Installment 3 will be due.

**Fee Hike:**

Please note that Fee Hike will be in the range of 8 to 10% annually.

Note that Fee will change as per the Grade Level as per the Fee Structure.
